**Para.4 :-** *Secretary informed the house that simply because we have crossed 500 + members, we shall not remain idle. There is a scope for enrolling more members at Coimbatore and Trichy. Also, we should try to induct more direct recruit JAOs as our members. He further elaborated that in the past, Trustees meeting was conducted at Vellore, Salem and Madurai, with the result a greater number of members joined our trust. Hence, he suggested to conduct AFSROA annual meet in the month of January at Coimbatore. Our Sr. Members from Trichy who were attended our Madurai Trustees meeting promised to conduct the trustees meeting at Trichy, in the month of May or June 2026. So we have to utilize these opportunities to enroll a greater number of members.*

**Para 9 and para 10:-** *The following members took part in the discussion and gave their suggestion for further improving the activities of our Trust.*

**1. Shri.C.Arumugam, Vellore.** *Shri.C.Arumugam, Vellore, suggested to consider extending Education assistance to 10<sup>th</sup> standard students. This is long pending demand from most of the coordinators and requested to implement it from 2026 onwards.*

**2. Shri.M.Palnivelu, Madurai.** *Shri.M.Palanivelu, Madurai, suggested that some of the Headmasters are recommending the BPL assistance not in conformity with our guidelines but according to their will and pleasure. He advised the coordinators, to be vigilant while recommending the BPL cases and only the deserving cases to be sent to secretary for approval.*

- 3. Shri.Abdul Salam, Trichy:-** *He spoke in favour of extending Educational Assistance to 10<sup>th</sup> Standard students. He suggested to reduce the cash award for the 12<sup>th</sup> Standard students, if there is shortage of funds.*
- 4. Shri.V.Karthikesan, Thanjavur:-** *He agreed with the proposal of Shri.C.Arumugam and Shri.Abdul Salam and appealed for extending the Educational Assistance for the meritorious 10<sup>th</sup> Standard students. If sufficient funds is not available, he advised to reduce the number of schools in the 12<sup>th</sup> category.*
- 5. Shri.A.Thomas, Chennai:-** *He appealed to increase the Educational Assistance amount to BPL students from the present Rs.1500/- In case of shortage of funds the number of beneficiary students may be reduced, by extending the benefit to only most deserving cases.*
- 6. Shri.P.Venugopal, Salem:-** *He expressed to extend the educational assistance for the meritorious 10<sup>th</sup> standard students and suggested to reduce the Budget allocation for BPL students.*
- 7. Shri.M.Govindarajan, Salem:-** *He advocated for extending the Educational Assistance scheme to Meritorious 10 th standard and close the BPL scheme.*
- 8. Shri.Rajamanickam, Erode:-** *He disagreed with the previous speakers who advocated for discontinuing the BPL student's scheme. He requested the Trust Management to continue the scheme and narrated some incidents and requested to extend the BPL scheme to other districts and increase the beneficiary students.*

**9. Shri.G.Muthukumaran, Karaikudi:-** *He requested not to reduce the educational assistance amount to 12<sup>th</sup> students. In fact, in the initial years, we have allocated Rs.5000/- per school and the same was increased to Rs.6000/- per school from 2021 only. At this stage, reducing the prize money as suggested by some members is not correct. He supported for continuing the BPL scheme, as most of the beneficiary students are either Single Parent /Parentless and girl students.*

**10. Shri.C.Duraiarasan, Thanjavur:-** *He expressed to reduce the number of 12<sup>th</sup> schools and appealed for continuing the BPL students' scheme as it is a best scheme and HMs are appreciating. More over all students selected are very deserving and hence it should be continued.*

*Then the Managing Trustee requested the secretary to sum up the discussion and consolidated proposal may be placed before the house for approval.*

**The Secretary placed the following proposals.**

1. *No. of Higher Secondary school is to be restricted to 200 schools and the Educational assistance (ie Prize money) will remain the same. (I st Rs.2500 / II nd Rs.2000 / III rd Rs.1500/-).*
2. *We may extend the Educational Assistance scheme to meritorious students of 10<sup>th</sup> standard from this year (i.e. Academic year 2025-2026). To start with we will identify 50 to 60 schools and the following category schools will get the priority.*
  - i) *ADW schools*
  - ii) *Tribal Welfare schools*
  - iii) *Physically challenged school*
  - iv) *Schools located in the Hilly and remote areas.*

*Educational Assistance will be @Rs.2500/-, Rs.2000/- and Rs.1500/-.*
