## Secretary's Interim report.

- 1. Membership:** - The total number of members as on 30<sup>th</sup> MAY 2026, was 540. Sixteen (16) new members joined our trust since last meeting. 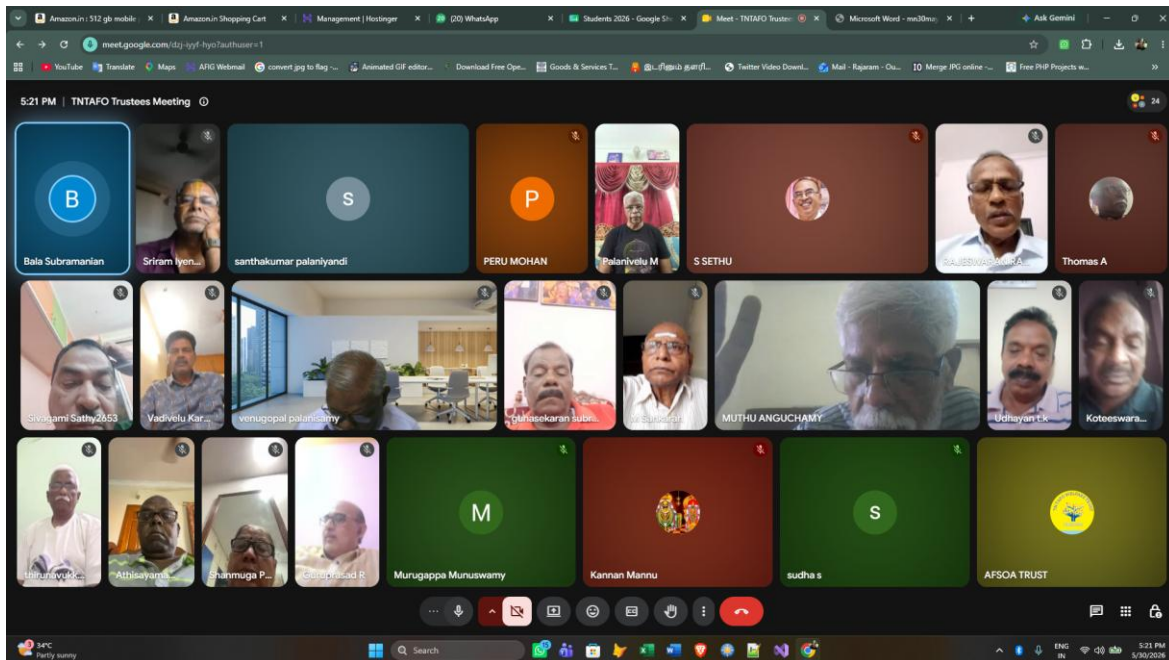
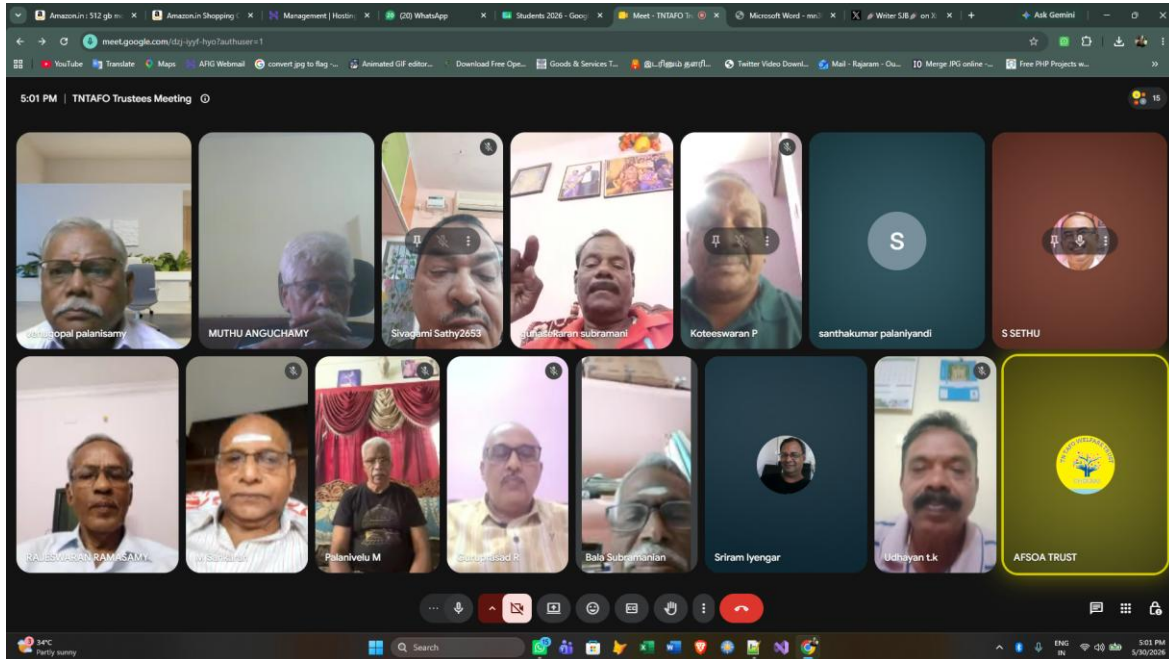
