All the CHQ office bearers stationed at N.Delhi attended the meeting. On 7.10.2016 a meeting was arranged in the Conf Hall of MTNL, Delhi. Even affter repeated phone call from Balasubramanian, Santhakumar, Hariharan & Sivakumar no initiative appears to have been taken by Shri Sathyanarayana to conduct the Mini conference. This August body can deliberate and give direction as to what further then action can he taken in this regard.
