2. Meetings

4. Educational assistance to Meritorious +2 students of Government Higher Secondary Schools

Our flagship scheme viz Educational assistance to meritorious +2 students studying in Govt. Hr. Sec. School is growing in leaps and bounds. The scheme is aimed at honouring and encouraging the meritorious rural poor students. Just 43 students were identified from 14 schools for giving cash award and merit certificate in the year 2018, and now in the current year i.e., 2023, 443 students from 146 school are the beneficiaries. The total number of students benefitted from this scheme during the last 6 year are 1455 and we have disbursed around 27 lakhs 50 thousand.

As per the suggestion received from Shri R. Ramachandran our Ex. Genl. Secretary, the Board of trustees approved to increase the Educational assistance from Rs. 5000 to 6000 per school Accordingly we have distributed Rs 2500/-, 2000/- and Rs 1500 to first three rank holders for the year 2022 and 2023. All our project Co-ordinators and their team members by their committed action have surpassed all our expectations by arranging function in a grand manner. In all the school our project Co-Ordinators have conveyed the message that our TNTAFO welfare Trust is here to share our love and take care of the educational needs of Rural poor students. All the HMs expressed their happiness and gratitude for the encouragement and honour extended to the students by our Trust.

Our Trust propose to increase the number of beneficiaries atleast to 50 poor students in the coming years. In the trustees meeting held on 7.9.2023 it was decided to extend Educational Assistance @ Rs.8,000/- for non-proffessional courses and @ Rs.10,000/- to professional courses from next academic year.

6. Educational scholarship to below poverty line students studying X, XI & XII Stds. in Government Schools.

This year (ie.2023) we have launched another ambitious scheme viz. Educational Scholarship to BPL students @ Rs.1500/- per year to the students studying X,XI, and XII std in Govt. schools Rs. 1,83,000 was disbursed to 122 students covering 13 districts. In the coming years the no. of beneficiaries will increase. This year, most of the beneficiaries are parentless, single parent child and girl students. We convey our thanks to shri V. Dakshinamurthy, our founder trustee and shri M.P. Rammohan DGM(F) retd Bangalore for giving this proposal.

7. Educational assistance to Narikurawar Education and welfare society

NEWS is an NGO giving quality education to Narikurawa community children at Eraiyur, Perambalur dist. At NEWS more than 60 students are staying as inmates and studying in different classes. All the students are BPL students. Mrs Swedha is incharge of this residential school and requested to extend our help to meet the food and educational expenses. During the period under review our Trust donated a sum of Rs.1,53,500 (One lakh fifty three thousand and five hundred) to this NGO. In the Board of trustees meeting held on 07-09-2023, it was decided to extend help to meet the salary expenditure of one teacher @ Rs.7500/- every month for the next one year. Mrs Swedha is the first Engineering graduate from Narikurawa

community. Though she got placement in MNC. But, she did not join the job and decided to devote her entire time for the upliftment of her community children.

8. Our Trust extended helping hands to the family of Deceased Casual labour of BSNL (late) A. Suresh at Cuddalore.

The Board of trustees decided to raise funds towards the family relief fund of late suresh. Cuddalore SSA who died at very young age leaving behind his wife and children. As there was no other source of income to support his family, Mg. Trustee appealed to our members to donate liberally. A sum of Rs.1,300,00/- was received as donation from 59 of our members and the same was handed over by Mg. Trustee in the form of FD to Mrs. Suresh on 30-11-22.

9. Medical Assistance to shri S. Palani TTA Tambaram Tel. Exch

Shri. S. Palani TTA Tambaram Tel. Exch. met with an accident and was incurring huge expenditure in a private hospital. Based on the request of family members for donation, we made an appeal to our members to donate liberally to meet the medical Expenditure. Our members were very generous and contributed a sum of Rs.73,000/- Shri. S. Palani recovered fully and conveyed his heartfelt thanks to our trust for the timely financial help of Rs.83,000/-.

10. Donations Received

During the year 2021-22 we have received donation to the tune of Rs 16,00,100/- and during 2022-23, we have received donation of Rs 13,65,313/- from 146 members and 17 donars. And this fin. year ie 2023-24, upto 30-10-2023, donation to the tune of Rs.11,87,711/- has been received. We convey our heartfelt thanks to all the donars. Our Trust is able to carry out lot of charitable activities because of the generous donations received from our members and donars. We seek their continued support and helding hands for carrying out lot more charitable activities in the coming years. Donation to our Trust is exempted under Sec. 80-G of Income Tax Act 1961 and the same is effective from 25th March 2023. Shri. R. Guru Prasad, Asst. TR played a very important role in getting 80-G approval. We convey our thanks to him.
