2. The last General Body Meeting was held on 05.11.2023 at Hotel Sri Saravana Bhavan Grand Style, Salem 4. A total of 64 members attended the meeting. 7. RELIEF TO THE VICTIMS OF NATURAL CALAMITY:

i) Michaung Cyclone in Chennai City

Our Trust provided money and materials to the needy people affected by the cyclone during December 2023.

Provision viz., rice, dhal, oil, vegetables etc., purchased to the tune of Rs.24,563/- and handed over to Deepam Trust, who have taken the onerous job of supplying food packets, bread etc., to the affected individual/family in and around Velacherry, Chemmanchery and Pallikaranai. Secretary and Additional Managing Trustee visited the NGO and 13.12.2023 and personally handed over the relief materials.

Distributed financial assistance at Rs.1000/- to 101 sanitation workers at Madhavaram, Madippakkam and Perumpakkam. We are very grateful to S/Shri. P.Somu, S.Gunasekaran, P.Koteeswaran and M.Munusamy who have volunteered without any hesitation and dedicated their time and energy in identifying the beneficiaries and conducted the distribution function smoothly. R.Guruprasad, K.Rajaram, A.Thomas, S.Venkatraman, S.Ramakrishnan, Smt. S.Sudha, P.Palani, Lakshmanan, Sethuram and Secretary participated in the function and distributed the financial assistance. On 20.12.2023 relief materials comprising big size mat, Bed sheet, Rice, Dhal, Bread, Biscuit, Candle etc., were supplied to 50 rural families residing in the outskirts of Meyyur village in Tiruvallur District. Total cost involved Rs.46,910/-. Shri. S.Srinivasan our member residing at Tiruvellur played a key role in procuring the relief materials and

carrying the same to the affected village. Shri. Vijayakanth a social worker and Shri. Jayakumar Teacher extended the necessary help for the smooth distribution of materials. S/Shri K.Rajaram, C.P.Ravikumar, P.Rajeswaran, E.V.Venkatesan, S.Srinivasan and Secretary distributed the relief materials.

li) Wayanad Landslide (KERALA)

Wayanad Landslide was one of the worst calamities in the history of Kerala State. More than 400 people lost their life and thousands of people lost their home and more than 10000 people admitted in the hospital. In order to help the victims of this natural calamity. We made an appeal for donation. The response from our members was spontaneous and contributed to the tune of Rs.3-10 Lakhs. And as per the decision taken in the trustees meeting we have donated the amount as detailed below:

8.EDUCATIONAL ASSISTANCE TO THE NEW SOCIETY

Narikurawa Educational Welfare Society is an NGO giving Quality Education to Narikurawa community children at Eraiyur, Perambalur District. More than 60 students are staying as inmates and studying in different classes. All the students are BPL students. During the period under review we have donated @ 7500/- per month to meet the salary expenses of one teacher. The total financial assistance extended was Rs.1,27,500/-. In addition, Rs.15,000/- donated to them to meet the expenditure in connection with national boxing championship held at Jammu on 02.06.2024. This amount was donated by Shri.A.Natesan our Senior Member.

9.EDUCATIONAL ASSISTANCE TO MERITORIOUS +2 STUDENTS OF GOVERNMENT HIGHER SECONDARY SCHOOL

Our flagship scheme viz., Educational assistance to meritorious +2 students studying in Government Higher Secondary School is growing in leaps and bounds and it entered the 8th year. The scheme is aimed at honouring and encouraging the meritorious rural poor students. On seeing

the success of this scheme, our members have donated generously, with the result, this year ie., 2024-25, we are able to extend this scheme to 204 schools covering 30 districts of Tamil Nadu and Pondicherry. The total number of students benefitted from this scheme during the last 8 years are 2646 and we have disbursed assistance to the tune of 51,07,500/-
